

These include the Member Status Unit, which is dedicated to making sure the employment data we have for your employees is complete and current. In this issue, we'd like to introduce you to Madeline Peters, who manages the Member Status Unit.

TRS members may not remember where they worked in 2005 or 2012, but Madeline and her team have the answers. They track where TRS members worked, how long they worked in each position, and what they earned. And when an employment inquiry gets complex,

Madeline has the skills and experience to straighten things out.

That's because Madeline has been a TRS employee for two decades, managing the Member Status Unit for the last 12. She oversees the team's daily operations to ensure the quality of all member service data. That data includes titles, salary, service breaks, vesting dates, and more. Her department also processes requests for optional service purchase, transfer-in service, tier reinstatement, and other changes that may have an impact on member status.

In Madeline's words, "I love working in the pension industry. I feel it's very important having service records up to date and accurate because it's about our members' dignity and financial security at retirement."

Summer Retirement Update

To date, nearly 1,600 members have filed for retirement this summer—with 1,094 choosing a retirement date of July 1.

The number of retiring members is comparable to the number from summer 2023, and lower than the number of retirees in summer 2022 and summer 2021.
